a/ The Environment and Ethics Officer to Rep constitutional motion

Proposer: Christina St Clair Seconded: Rhiannon Rees

This JCR notes that:

- The hard work of the current E&E Officers (Sally Hayward and Jen Lord) and thanks them.
- We have both Officer/Committee positions and rep positions within the JCR
- Environment and Ethics is currently held by one or two people as an Officer position
- The Environment and Ethics Officers do not sit on any College level committees. 12 (of 17) current Officers sit on college level committees (Entz, Discounts and E&E do not)

The JCR believes that:

- The duties of E&E Officers could be successfully fulfilled if E&E were a rep position
- Many Officer positions require a lot of skill learning over time and require a continuity of the Officer for a year.
- E&E does not require the same level of skill learning and continuity as other positions
- Changing to a rep would not negatively impact the awareness of E&E issues. The awareness of campaigns has been effectively raised by reps in the past. For example by LGBTQ reps running LGBTQ history month and by BME reps running Race 101 workshops.
- E&E efforts would not be disrupted by a termly change of rep (similar to Charities efforts)

This JCR resolves to:

- Remove the position of JCR E&E Officer and replace it with E&E Rep(s).
- Keep the current E&E Officers (Sally Hayward and Jen Lord) until the end of their term of Office (MT2015) and ratify new E&E rep(s) in Hilary 2016.
- Exclude E&E Officer in the upcoming JCR election (MT2015)

b/ The "Better Veggie Food" Motion

Proposer: Zoe Carmichael Seconded: Jen Lord and Sally Hayward (E&E

Officers)

This JCR notes that:

- **a.** Vegetarian/vegan options in hall often lack protein, or do not represent a nutritional, balanced meal.
- **b.** Some members of St John's JCR are reluctant to eat in hall regularly as a result of a).
- c. There are vegetarians/vegans and non-vegetarians in St John's JCR who would like the vegetarian options provided by hall to improve regarding a).

This JCR believes that:

- **a.** Going to hall can be an important part of social life in college and no-one should be excluded from this.
- **b.** Members of the college who currently choose not to eat meat and/or dairy products for ethical and/or environmental reasons should not be discouraged from eating in hall due to the meals on offer in hall.
- c. Members of the college who are interested in cutting down their meat and/or dairy consumption should not be discouraged from doing so due to the meals on offer in hall.
- **d.** By passing this motion, the catering staff may be more likely to respond to action directed at improving vegetarian hall food.

This JCR therefore resolves to:

a. Support the efforts of Domestic Secretaries, Environment and Ethics Officers, and other members of college as they talk to college about improving the vegetarian/vegan options hall provides.

c/ The "S.U.R.E" Charities Motion

Proposer: Ria Dinsdale Seconded: Jake Hurfurt

This JCR notes that:

- **a.** S.U.R.E Somerset Unit for Radiotherapy Equipment is a Somerset based cancer charity that provides essential radiotherapy equipment to the Beacon Centre at Musgrove Park Hospital. This ends the need for patients to travel long distances for important treatment.
- b. The Beacon Centre needs to purchase a new Big Bore CT Scanner/Simulator as the existing scanner provided by S.U.R.E will reach the end of its life in 2017. The CT Scanner is the first step in planning all radiotherapy treatment, it is used to accurately locate tumors, Replacement in 2017 is essential to avoid patients having to travel to long distances in the future for this first stage in their Radiotherapy treatment.

This JCR believes that:

- c. We should help S.U.R.E reach their £500,000 target to purchase a new Big Bore CT Scanner/Simulator for the Beacon Centre.
- **d.** We should help S.U.R.E in their work to ensure the Beacon Centre at Musgrove Park Hospital to remain a "Centre of Excellence"

e. Donate £300 to S.U.R.E (Somerset Unit for Radiotherapy Equipment

d/ The "Remembering Not to Forget" Motion

Proposer: Cecilia Peker Seconded: Danny Waldman (ex officio)

This JCR notes that:

- a. The term dementia describes a set of symptoms including memory loss, mood changes and problems with communication and reasoning. The progress of the condition gradually robs individuals of everything that makes them who they are.
- **b.** There are currently 800,000 people living with dementia in the UK, and more than 35 million people worldwide. This number is expected to almost double every 20 years.
- c. One in three people over 65 will develop dementia, but it can also affect younger people; over 40,000 people under 65 are currently living with dementia in the UK, and the number is predicted to be much higher as many people do not receive a diagnosis until much later.
- **d.** Dementia is not a natural part of the aging process. It is caused by a number of diseases that affect the brain. The most common is Alzheimer's, affecting 62% of those living with dementia, but there are many other kinds.
- e. Dementia research receives far less funding than other conditions of this prevalence.

This JCR believes that:

f. People living with dementia should be helped to live independently for as long as possible. As the condition progresses everything possible should be done to ensure they have a good quality of life and receive high standards of care.

- **g.** Families caring for someone with dementia should receive the support they desperately need.
- h. Additional research into treatments or a cure for dementia should be carried out.
- i. Public awareness and understanding of dementia should be raised.

This JCR therefore resolves to:

- j. Make a donation of £300 to Remembering Not to Forget (www.rememberingnottoforget.org.uk), a small charity established by Alumni Alison Turnbull (Modern Languages 1998 2002) in 2013 with the above stated aims.
- k. Host a Dementia Friends session delivered by Alison Turnbull in Michaelmas term.
- 1. Commit to additional fundraising to support this cause.

e/ The Schistosomiasis Control Initiative Charity Motion

Proposer: Zoe Carmichael Seconded: Tamsin Brown

This JCR notes that:

- a. Neglected tropical diseases kill an estimated 534,000 people worldwide every year
- b. Schistosomiasis Control Initiative (SCI) works in sub-Saharan Africa to supply drugs and health education to protect against schistosomiasis (bilharzia) and other Neglected Tropical Diseases caused by intestinal worms.
- c. SCI is one of a very few charities which focus exclusively on Neglected Tropical Diseases. NTDs are so-called because treatment is cheap and effective, but chronically underfunded due to lack of publicity (and therefore donations).
- **d.** SCI has a strong track record, and its cost-effectiveness is so high that it has been designated a "best buy" in public health by the World Health Organisation. The cost per treatment is around \$1.23.
- **e.** SCI is recommended as an effective charity by Giving What We Can, GiveWell and The Life You Can Save.

This JCR believes that:

- **f.** With people dying every day of preventable diseases, it is critical that we donate to the most effective charities possible.
- g. With further donations SCI will extend its operations, including to new countries like Zimbabwe.

This JCR therefore resolves to:

h. Donate £300 to the Schistosomiasis Control Initiative

f/ Against Malaria Foundation Donation Motion

Proposer: Rune Kvist Seconded: Dan Sowood

This JCR notes that:

a. There is clear evidence that some charities are orders of magnitude more effective than others. It also notes that malaria is a disease which i) kills an incredible number of people and ii) is easily avoided through provision of bed nets. It notes that distribution of bed nets is one of the most cost effective ways of saving lives. Lastly, it notes that all lives are equal and thus that money to charity should be spend in the way that helps the most people.

This JCR believes that:

b. More money should be allocated to charities that are particularly effective at addressing particularly neglected and tractable causes.

This JCR therefore resolves to:

c. Donate £5,000 to the Against Malaria Foundation, which is evaluated to be one of the world's three most effective charities by the independent charity evaluator, GiveWell.org

g/ Self-Defence Class (Financial Motion)

Proposer: Katy Haigh Seconder: Rhiannon Rees

This JCR notes that:

- 1. Harassment and violence of varying degrees of severity are ongoing problems in Oxford.
- 2. Self-defence classes aim to raise awareness of how these situations can arise and offer a means to learn how to best deal with them.
- 3. The self-defence classes proposed focus on one's natural reactions as well as tailoring the classes to an individual's specific strengths rather than weaknesses.
- 4. These classes have been highly recommended by Trinity and Mansfield Colleges.

This JCR believes that:

- 1. Everybody has the right to feel safe and at ease while in Oxford.
- 2. Equipping members of our JCR with the skills to protect themselves and develop a better sense of self-awareness is important.

This JCR resolves:

- 1. To give [£600] in order to pay for 4 weeks of self-defence classes provided by the leader of the Krav-Maga society at Oxford Brookes University to be held in Kendrew events on Wednesday evenings of weeks 4, 5, 6 and 7 of Michaelmas Term. This would be amended to £300 if Balliol agree to split the cost with us.
- 2. That two of the four classes will be restricted to those who identify partly or wholly as women: this is in order to ensure some classes are tailored to focus on the scenarios most commonly faced by women. The other two sessions will be open to all genders and cover a wider range of scenarios.

h/ The College leafblower

Proposer: Harriet Stooke Seconded: Leo Garwood

This JCR notes that:

- a. The college has leafblowers
- b. The leafblowers make noise

- c. The college proceeds to use the leafblowers as early as 8am
- d. Students of the college are woken up as early as 8am as a result of the noise produced by the leafblowers

This JCR believes that:

- e. The leafblowers shouldn't govern when students of the college wake up
- f. There are a number of alternative strategies to leaf management such as using leafblowers at a different time of day and using quieter methods to manage the leaves

This JCR therefore resolves to:

g. Confer with college and put pressure on them to use an alterative and less disruptive strategy of leaf management

i/ Money and Support for Pro-Grants Demonstration

Proposer: Thomas Wadsworth Seconder: Michael Muir

JCR Notes That:

- 1. That plans to scrap maintenance grants for low income students in September 2016 have been announced
- 2. That tuition fees and living costs are already very high and cause significant debt for most students
- 3. That there has been a national demo called in London on November 4th against these cuts to grants and for a free education
- 4. That this demo is being supported by the NUS national executive committee
- 5. That a full risk assessment of the demonstration is being undertaken by the NUS and OUSU6. That NCAFC, working with NUS, have taken measures to ensure that the demo is as accessible as possible and there will be a disabled students' bloc at the front of the demo
- 7. Last year, OUSU Council voted to support the NUS campaign for free education and put forward £200 to the cost of a coach to the national demonstration. It was also passed by fifteen JCRs. John's also gave money to contribute towards coach costs.
- 8. At the last OUSU Council in 1st week a motion was passed opposing the abolition of maintenance grants where all but 7 people voted for it.
- 9. OUSU is currently part of a national lobbying movement against the abolition of maintenance grants
- 10. That Keble and Hertford JCRs have already passed £150 each towards the cost of organising Oxford coaches to the demonstration and a motion will be brought to OUSU at the next council
- 11. We are richer than both Keeble and Hertford and have a long history of allowing a wide variety of political opinions to express themselves

The JCR Believes That:

- 1. That maintenance grants provide a crucial way for many students to actually access higher education, and as such should not be abolished
- 2. That cuts to these grants will disproportionately affect marginalised groups, in particular students from working class backgrounds and students with disabilities, for whom the grants are a lifeline
- 3. Students who want to attend the march and express their opinions should have the ability to do so and cost is a prohibiting factor in this instance

The JCR Resolves To:

- 1. To pass £200 to go towards funding the two coaches needed to accommodate people to bring them to and from the campaign on the day
- 2. To mandate the JCR President to email the JCR with information about the demonstration in the next weekly update
