a/ Disabilities Rep to Officer Motion

Proposer: Thomas Wadsworth Seconder: Katy Haigh

The JCR notes that:

- a. Ableist language and accessibility issues are a common occurrence around Oxford and the college, and this drastically lowers the welfare of those affected
- b. There is currently a women's officer on the committee who represents only one of the liberation campaigns
- c. The MCR have the Disabled Students Officer on their committee
- d. Intersectionality is important
- e. The position of the disabilities rep is overlooked for those on the committee when people wish to go to someone for information
- f. It can be difficult to get people to run for rep roles, especially when they are mandated to do a lot

The JCR believes that:

- g. There is a lot that needs to be done in college to resolve and represent disabilities issues
- h. All liberation groups deserve equal support and have the recognition and ability to carry out the needed actions
- i. The liberation groups should be represented by someone who identifies as such with the movement

The JCR therefore resolves to:

- j. Mandate the JCR disabilities rep/student disabilities officer to hold a disabilities discussion group/surgery at least once every two weeks for a 1 hour minimum
- k. Mandate the JCR disabilities rep/student disabilities officer to raise awareness of the role and the informational facilities it provides
- l. Mandate the JCR disabilities rep/student disabilities officer to hold a disabilitea and an awareness event at least once a term
- m. Mandate the JCR disabilities rep/student disabilities officer to improve the accessibility of events held by the JCR to the best of their ability
- n. Mandate the JCR disabilities rep/student disabilities officer to run and organise a disabilities buddy system (along the same lines as the college parents system but with paired volunteers and freshers with similar disabilities)
- o. Remove all of Table Two B. 2f (<u>The Disabilities Action Rep</u> shall be responsible for the promotion of disability issues within College and for disabilities action campaigns. S/he shall work closely with the Access and Equal Opportunities Officer to increase awareness of disability issues, including access, and to promote applications from disabled people. S/he shall normally attend OUSU Disabilities Action Committee. Appointed by the JCR Committee and ratified by a JCR meeting. S/he shall report to the Access and Equal Opportunity Officer.)
- p. Add a new paragraph reading: The Student Disabilities Officer shall represent and support the views and issues around disabilities in the JCR, when sitting on the JCR committee, the Equality Committee, any other committees appointed to on a college or wider university level, and in their work around college. They should provide an arena for discussion, holding a disibilitea and an awareness event at least once a term, as well as providing a space to talk through a designated discussion group/surgery. This should be held at least once every two weeks for a minimum of an hour. They should represent the college in OSDC, through contacting the OSDC president and trying, to the best of their ability, to get involved through socials and on the committee. The student disabilities officer should also strive to make sure that all events are held in accessible environments, and where they cannot, try to improve it to the best extent they can. They should also work closely with the MCR officers to help improve the situation in college further.
- q. Add d) to Table Three: Standard Orders for the Election of Officers 1. Only full members of the JCR who identify as disabled should stand for the position of student disabilities officer.
- r. Add a clause stating that anyone can vote for the position but adding a conscience clause stating that people should think about whether the position is actually relevant to them and whether they should actually vote for it
- s. Leave the exact wording up to the constitutional reform committee as long as any wording changes are non-functional

b/ Prescription Costs Motion

Proposer: Thomas Wadsworth Seconder: Jess Colston

The JCR notes:

- a. That prescription charges in England are currently set at £8.20 per medicine or appliance dispensed.
- b. That the majority of students are over 18 and therefore not eligible for free prescriptions unless on the NHS low income scheme.
- c. That although students may be eligible for help with healthcare costs through the NHS Low Income Scheme (LIS), the complex application process is a barrier for disabled students particularly during high-stress Oxford terms.
- d. That Prescription Prepayment Certificates (PPCs) can reduce prescription charge costs but still represent an often impossible financial burden, with a three month certificate at £29.10 and an annual certificate at £104
- e. That a survey conducted of 84 Wadham students found that roughly 31% of students have regular prescriptions without using the LIS or PPCs. A further 7% have 3 or 12 month PPC. (I don't have the data or time to conduct one at John's but I imagine the figures are relatively close to this)

The JCR believes:

- f. That prescription charges often force students to choose between medication and other living costs and are therefore a barrier to healthcare.
- g. That the foundational principle of the NHS -- that treatment should be free at the point of delivery -- should be defended at any cost.
- h. That we cannot allow students to face unfair additional charges for basic necessities.
- i. That disabled students face unique and under-acknowledged challenges, including hidden costs that accompany being disabled at university, and that we stand in solidarity with them.

The JCR resolves to:

- j. To mandate the Disabilities Rep to create a committee to judge the best method of reimbursing prescription charges and prescription prepayment certificates for all members of the JCR.
- k. To mandate the Disabilities Rep Officer to act on the findings of said committee.
- l. To mandate the Disabilities Rep to make information about the NHS Low Income Scheme (LIS) available and to help students who may wish to apply or to refer them to the Welfare Advisor.
- m. To create a new termly levy of £12 to equalise the cost of prescriptions for all students, significantly reducing the burden on students whose costs exceed the average (Open for debate the £12 levy should cover all costs without the JCR having to pay anything extra. If we can spend some of the JCR budget each term instead then this levy can be reduced.)
- n. To review the efficacy of this levy at the end of each year.

c/ Begging Motion

Proposer: Charlie Clegg Seconder: Beth Candlin

This JCR notes, believes, and resolves:

As D.V.D. Rep', I'm in charge of an already generous £200 annual budget to spend on D.V.D.s. This year, however, I'm very close to over-spending and with requests coming in frequently, I'll need more money to keep up with these. I believe what I have purchased thus far this year has greatly furnished the collection as a means of educating (with box sets like 'Shoah'); entertaining (what is 'Frozen' if not entertainment?); and providing a top notch collection of high quality film and television (with 'Borgen' and 'Lawrence of Arabia' as notable examples). I emphasise that this request is a one-off and I will be happy to see how the usual budget pans out next year. If you pass this motion, you'll be able to enjoy the D.V.D. collection that little bit better as I'll be a little freer to add what you want to watch.

This JCR believes that:

- **c.** A Sports Rep. would be a point of call for all the sports teams in college to have a go to person.
- **d.** A Sports Rep. could promote use of the gym, sports grounds and the fitness classes in college.
- e. A Sports Rep. could liaise with college on matters about the facilities.
- f. A Sports Rep. could come up with ways to promote exercise and healthy lifestyles.
- g. A Sports Rep. could encourage all sports in college.

This JCR therefore resolves to:

h. Ratify a Sports Rep.

e/ Thank You and Farewell :(

This JCR notes that:

- a. The JCR typically buys a dinner for their Committee and the end of their term.
- **b.** One of our Welfare Officers, the Women's Officer, and the Academic Affairs Officer will not be here when the Committee's term ends in Michaelmas.
- c. These Officers have done good work over their two terms in office.
- d. The Academic Affairs Officer's opposition to providing meals to Officers.

This JCR believes that:

e. We should thank our Officers for their work, regardless of whether they are here when we typically show our thanks.

This JCR therefore resolves to:

f. Buy Beth Candlin and Lidia Fanzo a meal, or vouchers for takeaway, or a G&Ds bloodbath, or something of equivalent value that takes their fancy to say thank you for the work they've done, up to a value of £25 per head.

f/ Union Cocktail Motion

The St John's College JCR notes: The Oxford Union has produced a cocktail making light of colonialism and slavery. This JCR opposes racism and colonialism and is committed to creating an inclusive environment.

This JCR believes: Imagery and behaviour of this kind by a prestigious organisation with close ties to the university must be condemned by this JCR in order to contribute to the creation of an inclusive environment in the JCR.

This JCR also condemns the Union's failure to engage and communicate with its BME representative, both after the discovery of the cocktail, and during the representative's entire time in the position.

This JCR believes this lack of engagement with the Liberation reps suggests that their positions are being treated more as figures for political correctness, rather than a means for marginalised voices to be given a say in the Union.

This JCR resolves: To formally condemn the behaviour of the Oxford Union and to have the executive committee contact both the Union and the Student papers to publicise its condemnation.

This JCR also resolves to have the executive committee contact the OUSU president to request the Union is barred from using OSSL (The student email service run by OUSU). Failing this the executive is to request a list of the Union scandals is distributed alongside it's advertising emails.
